- I will not use Internet chat.
- If I see anything I am unhappy with or I receive messages I do not like, I will tell a teacher immediately.
- I understand that if I deliberately break these rules, I could be stopped from using the Internet or computers.

Dear Parents

Responsible Internet Use

As part of your child's curriculum and the development of ICT skills, our school is providing supervised access to the Internet. We believe that the use of the World Wide Web and e-mail is worthwhile and is an essential skill for children as they grow up in the modern world.

The internet provides access to a greater library of resources than could ever be provided in school. However, where as the resources in school are carefully selected to be consistent with national and school policies those on the internet are not. Pupils also have the opportunity to use email to exchange messages with other internet users in others schools. As parents you are obviously aware that some material accessible via the internet is inappropriate and unsuitable for us. We believe that with clear and strict supervision, however, the children will benefit educationally from using the internet. The school will, of course, respect the rights of each family to decide whether or not to allow access.

Although there have been concerns about pupils having access to undesirable materials, we are taking positive steps to deal with this risk in school. During school, teachers will guide pupils towards appropriate material, and the school's service provider will employ measures to protect against access to inappropriate materials, procedures which will ensure that pupils only use the internet to further educational goals and objectives.
